SUBJECT : Deputation as Forest Officers of the eight  
(8) concession guards of Woodworks, Inc.,  
Naga City.

S i r :

Pursuant to Section 80 of Presidential Decree No. 705, as amended, you are hereby deputized as Forest Officer of the Bureau of Forest Development, Department of Environment and Natural Resources, effective upon receipt hereof, of which this Office shall be informed accordingly.

By virtue of this deputation, you are authorized to detect/investigate violations of forestry laws, rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in Chapter IV of Presidential Decree No. 705, as amended, within your territorial jurisdiction. You are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products, cut, gathered or removed by the offenders in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscations, you shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with the appropriate officials designated by law to conduct preliminary investigation and file the information in court, through the District Forester or Regional Director concerned.


Pursuant to Section 45 of PD 705, you are authorized

to administer and oath and take acknowledgment in official matters connected with the functions of your Office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

You shall submit to the Regional Director of Bureau of Forest Development, Region 5, Naga City a monthly report of the cases you have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of your services in said company.


