DENR MEMORANDUM ORDER NO. 2024 - ^{@1}

SUBJECT: IMMEDIATE ASSESSMENT OF ABANDONED, UNDEVELOPED (UNUSED) AND UNDERUTILIZED (AUU) AREAS RELEASED BY THE DENR TO DA-BFAR FOR FISHPOND PURPOSES IN SELECTED REGIONS

Pursuant to Presidential Directive No. 2023-296 regarding the Review of Areas with Fishpond Lease Agreements that are Abandoned, Unused, and Underdeveloped (AUU), the immediate assessment of said areas shall be undertaken initially in selected provinces within the following DENR Regional Office Nos. 5, 6 and 9.

The Regions shall be guided by the following procedure:

- I. The DENR Regional Office shall mobilize a DENR Regional Field Assessment Team to be composed of the following Offices:
 - Conservation and Development Division
 - Survey and Mapping Division
 - License, Patents and Deeds Division
 - PENR Office/Implementing PENR Office
 - CENR Office
- II. The team shall gather the following data:
 - 1. National Mapping and Resource Information Authority (NAMRIA) data (topographic maps, fishpond maps, mangrove swamp zonification, and land classification map, 2020 land cover map),
 - 2. Total forestlands released to DA-BFAR for fishpond purposes;
 - Fishpond Suitability for Mangrove Rehabilitation, Vulnerable Areas to Sea level rise and flooding maps from DENR Geospatial Database Office;
 - DA-BFAR data [issued Fishpond Lease Agreements (FLAs), active, cancelled, expired, terminated and AUU, including maps and technical descriptions (bearing and distance format), illegal fishponds];
 - 5. List and details (e.g. location, etc.) of AUU- FLAs already reverted to DENR:
 - Property Identification maps and List of Fishpond Lots, lot numbers and tenurial status from Municipal Assessor's Office;
 - 7. Mangrove area released to DA-BFAR but no FLAs issued:

- 8. Mangrove areas not included in the areas released to DA-BFAR by DENR but issued with FLAs/fishponds;
- 9. FLAs with Certificate of Land Ownership Award (CLOA) or with title;
- 10. Forestlands with CLOA with Fishponds but no FLA;
- 11. Fishponds within mangrove swamps, forest reserves (Presidential Proclamation Nos. 2151 and 2152) and other protected areas; and
- 12. Fishponds in areas with other management arrangements.

Data gathering may be done simultaneously with ground validation.

- III. Data Consolidation and Initial Deskwork Validation. The Assessment Team shall consolidate and harmonize the gathered data as listed above and shall validate the same with DA-BFAR data.
- IV. Desktop Mapping. The Assessment Team shall overlay the FLA area on the control maps, as listed above, and cross check the current land use of the area. They shall create a base map to serve as reference for the ground validation. The DENR One Control Map may also be utilized for this activity. The Assessment Team will also determine if the FLAs complied with other relevant rules and regulations, such as but not limited to the provisions in the Presidential Decree No. 1067 or the "Water Code" on easements and PD No. 1586 or the "Philippine Environmental Impact Statement System" on securing an Environmental Compliance Certificate.
- V. **Ground Validation.** Members of the Assessment Team shall conduct ground truthing and validation to assess the status and existing land use of the identified areas released by DENR to DA-BFAR for fishpond purposes. The assessment team may request assistance from the Philippine National Police and the concerned Local Government Unit in the conduct of the ground truthing/validation. The template for field validation is provided herein as **Annex A**.
- VI. Analysis of Data and Report Writing. The Assessment Team shall analyze the consolidated data and maps, and the results of the ground validation. They shall prepare a report, to include identified AUU areas with the attached maps. The Assessment Team shall conduct consultations with concerned stakeholders such as CSOs, Academe and LGUs. The Assessment Team shall submit the report to the Regional Technical Working Group (RTWG) created under Special Order (SO) No. 2021-274¹.
- VII. Recommendation of Areas for Administrative and Biophysical Reversion. The RTWG shall review the report. Based on the findings, the RTWG shall recommend areas for administrative and biophysical reversion in accordance with the criteria listed under *Annex A-III*

Category, and endorse it to the National Technical Working Group (NTWG) created under SO No. 2021-274.

VIII. **Submission of Recommendation.** The NTWG shall review the reports and recommendations of the Regions and submit its recommendations to the Secretary on the administrative and biophysical reversion, as may be appropriate.

This Order takes effect immediately.

- H. Date of Expiration; and
- I. Other tenurial instruments.

The information on biophysical status of the FLA shall also be collected, such as but not limited to the following:

- A. Remaining mangrove Cover (in hectares),
- B. Mangrove Species composition,
- C. Adjacent/adjoining habitats,
- D. Current land use, and establishments within/near the area.

They will also note the issues, concerns and challenges and provide recommendations or needed actions on the area.
