By virtue of this deputation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest Pevelopment and to arrest, even without warrant, any person who has committed, is permitting or is about to commit in your presence any of the offenses defined in latitude for, 60, 70, 71 and 77 of Presidential Decree No. 705, within your attractional jurisdictions. They are also authorized to seize/confiscate the tools are missed in committing the offense and the forest products cut, gathered to the confiscation, account and or seizure or confiscations, they shall deliver the period prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper

complaint with, the appropriate official designated by law to conduct proliminary investigation and file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their Office, and to take testimony in official investigations conducted under the sutherity of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester, Cagayan de Oro City menthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their many of Office unless sooner terminated by this Office.
