By virtue of this deputation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest Discipling of and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in otions 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered a reserved by the offender/s in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscations, they shall deliver the period prescribed by law from the time of arrest and seizure, the offender of the confiscated forest products, tools and equipment too, and file the proper

plaint with, the appropriate official designated by law to conduct liminary investigation and file the information in court through the District Forester or Regional Director.

Forsuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their willies, and to take testimony in official investigations conducted under the extherity of the Revised Forestry Code of the Philippines and its implementing under and regulations.

They shall submit to the <u>District Forester</u>, <u>Bayugan</u>, <u>Agusan</u>, <u>del</u> Sur monthly report of the cases they have handled pursuant to this Order.

this deputation shall be automatically revoked upon termination of their tenure of Office unless sooner terminated by this Office.
