By virtue of this deputation, they are authorized to detect violations of corestry laws/rules and regulations administered by the Bureau of Forest laws/rules and regulations administered by the Bureau of Forest laws/rules and to arrest, even without warrant, any person who has committed, is possibling or is about to commit in your presence any of the offenses defined in without 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your ritorial jurisdictions. They are also authorized to seize/confiscate the tools component used in committing the offense and the forest products cut, gathered reserves by the offender/s in the process of committing the offense. In all the serf detection, arrest and/or seizure or confiscations, they shall deliver that period prescribed by law from the time of arrest and seizure, the offendation confiscated forest products, tools and equipment too, and file the proper

complaint with, the appropriate official designated by law to conduct potallorinary investigation and file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their britise, and to take testimony in official investigations conducted under the rutherity of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the <u>District Forester</u>. Cagavan de Oro City wenthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their tenure of Office unless sooner terminated by this Office.
