Pursuant to Section 80 of Presidential Decree No. 705, the following are by deputized as FOREST OFFICERS of the Ministry of Natural Resources/Bureau of Forest Development, effective upon receipt hereof, of which this Office shall be informed accordingly.

Barangay Chairman/Captains Barangays 1. Arturo A. Abregana San Antonio East 2. Benedicto Abbu. Sr. Minsalagan 3. Lorenzo M. Bances Singguyan 4. Simeon R. Bragat Pinamaloy 5. Ireneo Polinar Old Nongnongan 6. Eduardo Baculio San Francisco 7. Vicente Inguito Kawilihan Hadje S. Sumatra 8. Bocboc

By virtue of this deputation, they are authorized to detect violations of forestry laws/rules and regulations administered by the Bureau of Forest Desclopment and to arrest, even without warrant, any person who has committed, is remnitting or is about to commit in your presence any of the offenses defined in Sections 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools to comprent used in committing the offense and the forest products cut, gathered or removed by the offenders in the process of committing the offense. In all the more of detection, arrest and/or seizere or confiscations, they shall deliver that confiscated forest products, tools and equipment too, and file the proper

complaint with, the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their Office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the <u>District Forester</u>, <u>Malaybalay</u>, <u>Bukidnon</u> a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their feaure of Office unless sooner terminated by this Office.
