By virtue of this deputation, they are authorized to detect violations of forestry laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in Sections 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and coulpment used in committing the offense and the forest products cut, gathered or removed by the offender/s in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper

polylatint with, the appropriate official designated by law to conduct pulliminary investigation and file the information in court through the District Factor or Regional Director.

Fursuant to Section 45 of PD 705, they are authorized to administer an oath mad take acknowledgement in official matters connected with the functions of their before, and to take testimony in official investigations conducted under the atherity of the Revised Forestry Code of the Philippines and its implementing and regulations.

They shall submit to the <u>District Forester</u>, San Francisco, Agusan del a monthly report of the cases they have handled pursuant to this Order. Sur

This deputation shall be automatically revoked upon termination of their tenure of Office unless sooner terminated by this Office.
