Py virtue of this deputation, they are authorized to detect violations of forestry laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in 18 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your 19 mill jurisdictions. They are also authorized to seize/confiscate the tools 19 pment used in committing the offense and the forest products cut, gathered 19 vice by the offender/s in the process of committing the offense. In all 19 of detection, arrest and/or seizure or confiscations, they shall deliver 19 period prescribed by law from the time of arrest and seizure, the offender 19 confiscated forest products, tools and equipment too, and file the proper

complaint with, the appropriate official designated by law to conduct continuous investigation and file the information in court through the District crester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their side, and to take testimony in official investigations conducted under the strong of the Pevised Forestry Code of the Philippines and its implementing has and regulations.

They shall submit to the <u>District Firester. Kalibo. Aklan</u> thly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their or of Office unless sooner terminated by this Office.
