By virtue of this deputation, they are authorized to detect violations of Forestry laws/rules and regulations administered by the Bureau of Forest violopment and to arrest, even without warrant, any person who has committed, is unitting or is about to commit in your presence any of the offenses defined in tons 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your retorial jurisdictions. They are also authorized to seize/confiscate the tools supposed used in committing the offense and the forest products cut, gathered or removed by the offender/s in the process of committing the offense. In all tances of detection, arrest and/or seizure or confiscations, they shall deliver in the period prescribed by law from the time of arrest and seizure, the offender the confiscated forest products, tools and equipment too, and file the proper

is at with, the appropriate official designated by law to conduct inary investigation and file the information in court through the District in or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath take acknowledgement in official matters connected with the functions of their fire, and to take testimony in official investigations conducted under the crity of the Revised Forestry Code of the Philippines and its implementing makes and regulations.

They shall submit to the District Forester, Kalibo, Aklan monthly report of the cases they have mandled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their nurs of Office unless sooner terminated by this Office.
