By virtue of this deputation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest violations administered by the Bureau of Forest violations and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in 30.100 s 68, 59, 70, 71 and 77 of Presidential Decree No. 705, within your previolations. They are also authorized to seize/confiscate the tools without used in committing the offense and the forest products cut, gathered world by the offender/s in the process of committing the offense. In all the period prescribed by law from the time of arrest and seizure, the offender are confiscated forest products, tools and equipment too, and file the proper

plaint with, the appropriate official resignated by law to conduct ; winnary investigation and file the information in court through the District Purester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their Tice, and to take testimony in official investigations conducted under the observity of the Revised Forestry Code of the Philippines and its implementing 's and regulations.
