By virtue of this deputation, they are authorized to detect violations of fore try laws/rules and regulations administered by the Bureau of Forest v lopeont and to arrest, even without warrant, any person who has committed, is " "mitting or is about to commit in your presence any of the offenses defined in Lons 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your r torust jurisdictions. They are also authorized to seize/confiscate the tools rulpment used in committing the offense and the forest products cut, gathered memored by the offender/s in the process of committing the offense. In all the les of detection, arrest and/or seizure or confiscations, they shall deliver then the period prescribed by law from the time of arrest and seizure, the offender: $au au ag{0}$ confiscated forest products, tools and equipment too, and file the proper

with, the appropriate official resignated by law to conduct any investigation and file the information in court through the District or Regional Director.

Fursuant to Section 45 of PD 705, they are authorized to administer an oath med lake acknowledgement in official matters connected with the functions of their lifter, and to take testimony in official investigations conducted under the elective of the Revised Forestry Code of the Philippines and its implementing along and regulations.

They shall submit to the District Forester. Kalibo. Aklan certhly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their of Office unless sooner terminated by this Office.
