By virtue of this deputation, they are authorized to detect violations of forestry laws/rules and regulations administered by the Bureau of Forest valopment and to arrest, even without warrant, any person who has committed, is mitting or is about to commit in your presence any of the offenses defined in tions 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your ritorial jurisdictions. They are also authorized to seize/confiscate the tools equipment used in committing the offense and the forest products cut, gathered ramoved by the offender/s in the process of committing the offense. In all takes of detection, arrest and/or seizure or confiscations, they shall deliver the period prescribed by law from the time of arrest and seizure, the offender the confiscated forest products, tools and equipment too, and file the proper

laint with, the appropriate official designated by law to conduct liminary investigation and file the information in court through the District calester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their Office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing mules and regulations.

They shall submit to the District Forester, San Jose, Antique a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their tenure of Office unless sooner terminated by this Office.
