By virtue of this deputation, they are authorized to detect violations of a forestry laws/rules and regulations administered by the Bureau of Forest evalopment and to arrest, even without warrant, any person who has committed, is consisting or is about to commit in your presence any of the offenses defined in tions 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your ritorial jurisdictions. They are also authorized to seize/confiscate the tools pulpment used in committing the offense and the forest products cut, gathered manded by the offender/s in the process of committing the offense. In all these of detection, arrest and/or seizure or confiscations, they shall deliver the period prescribed by law from the time of arrest and seizure, the offender the confiscated forest products, tools and equipment too, and file the proper

plaint with, the appropriate official designated by law to conduct a liminary investigation and file the apportation in court through the District ester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath of take acknowledgement in official matters connected with the functions of their loc, and to take testimony in official investigations conducted under the crity of the Revised Forestry Code of the Philippines and its implementing and regulations.

They shall submit to the District Forester, Moilo City we they report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their are of Office unless sooner terminated by this Office.
