They are also authorized to seize/confiscate the tools coulpment used in committing the offense and the forest products cut, gathered lendered by the offender/s in the process of committing the offense. In all labour of detection, arrest and/or seizure or confiscations, they shall deliver the period prescribed by law from the time of arrest and seizure, the offender the confiscated forest products, tools and equipment too, and file the proper

Firt with, the appropriate official lesignated by law to conduct inary investigation and file the information in court through the District ter or Regional Director.

Pursuant to Section #5 of PD 705, they are authorized to administer an oath take acknowledgement in official matters connected with the functions of their fice, and to take testimony in official investigations conducted under the chority of the Revised Forestry Code of the Philippines and its implementing les and regulations.

They shall submit to the District Forester, Barotoc Nuevo, Iloilo orthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their  $\pi r$  of Office unless sooner terminated by this Office.
