They are also authorized to seize/confiscate the tools reuipment used in committing the offense and the forest products cut, gathered removed by the offender/s in the process of committing the offense. In all tences of detection, arrest and/or scizure or confiscations, they shall deliver in the period prescribed by law from the time of arrest and seizure, the offender ne confiscated forest products, tools and equipment too, and file the proper
