forestry laws/rules and regulations administered by the Bureau of Forest lopment and to arrest, even without warrant, any person who has committed, is reliting or is about to commit in your presence any of the offenses defined in ions 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and compment used in committing the offense and the forest products out, gathered or removed by the offender/s in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper

t with, the appropriate official or signated by law to conduct tery investigation and file the information in court through the District or Regional Director.
