SUBJECT : Deputizing the Barangay Captains of Kabankalan,  
Negros Occidental  
as Forest Officers of the  
Ministry of Natural Resources.

Pursuant to Section 80 of Presidential Decree No. 705, the following are hereby deputized as FOREST OFFICERS of the Ministry of Natural Resources/Bureau of Forest Development, effective upon receipt hereof, of which this Office shall be informed accordingly.

By virtue of this deputation, they are authorized to detect violations of forestry laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in sections 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered and removed by the offender/s in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscations, they shall deliver the same within the period prescribed by law from the time of arrest and seizure, the offender/s, the confiscated forest products, tools and equipment too, and file the proper



... regulations.


... shall submit to the District Forester, Kabankalan, Negros Occ.
