By virtue of this deputation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest 5 viloprent and to arrest, even without warrant, any person who has committed, is perfectling or is about to commit in your presence any of the offenses defined in strong 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your tritorial jurisdictions. They are also authorized to seize/confiscate the tools as supposed used in committing the offense and the forest products cut, gathered a manager by the offender/s in the process of committing the offense. In all these s of detection, arrest and/or seizure or confiscations, they shall deliver the time of prescribed by law from the time of arrest and seizure, the offender the confiscated forest products, tools and equipment too, and file the proper

They shall submit to the District Forester, Mati, Davao Oriental monthly report of the cases they have handled pursuant to this Order.
