By virtue of this deputation, they are authorized to detect violations of forestry laws/rules and regulations administered by the Bureau of Forest viologment and to arrest, even without warrant, any person who has committed, is respectively or is about to commit in your presence any of the offenses defined in Lons 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your principal jurisdictions. They are also authorized to seize/confiscate the tools assignment used in committing the offense and the forest products cut, gathered are numbered by the offender/s in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscations, they shall deliver it to be period prescribed by law from the time of arrest and seizure.
