By virtue of this deputation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest for lopment and to arrest, even without warrant, any person who has committed, is permitting or is about to commit in your presence any of the offenses defined in thions 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your principal jurisdictions. They are also authorized to seize/confiscate the tools authorized by the offender/s in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscations, they shall deliver ithin the period prescribed by law from the time of arrest and seizure—the offender

aplaint with, the appropriate official designated by law to conduct liminary investigation and file the information in court through the District Porester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their affice, and to take testimony in official investigations conducted under the reductive of the Revised Forestry Code of the Philippines and its implementing les and regulations.
