y virtue of this deputation, they are authorized to detect violations of ratry laws/rules and regulations administered by the Bureau of Forest toward and to arrest, even without warrant, any person who has committed, is itsing or is about to commit in your presence any of the offenses defined in twons 68, 69, 70, 71 and 77 of Precidential Decree No. 705, within your ritorial jurisdictions. They are also authorized to seize/confiscate the tools a suipment used in committing the offense and the forest products cut, gathered removed by the offender/s in the process of committing the offense. In all standard of detection, arrest and/or seizure or confiscations, they shall deliver the period prescribed by law from the time of arrest and seizure.

t with, the appropriate official designated by law to conduct ry investigation and file the information in court through the District . or Regional Director.

recognit to Section 45 of PD 705, they are authorized to administer an oath thate acknowledgement in official matters connected with the functions of their lake, and to take testimony in official investigations conducted under the therity of the Revised Forestry Code of the Philippines and its implementing rden and regulations.

They shall submit to the District Forester, Nabunturan, Davao del Norte monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their nure of Office unless sooner terminated by this Office.
