**REJECT : Deputizing the Barangay Captains of Asuncion, Davao del Norte as Forest Officers of the Ministry of Natural Resources.**

In the course of this deputation, they are authorized to detect violations of forest laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or about to commit in your presence any of the offenses defined in Sections 9, 10, 71 and 77 of Presidential Decree No. 705, within your respective jurisdictions. They are also authorized to seize/confiscate the tool/equipment used in committing the offense and the forest products cut, gathered or stored by the offender/s in the process of committing the offense. In all cases of detection, arrest and/or seizure or confiscations, they shall deliver the same within the period prescribed by law from the time of arrest and seizure. The offenders



... pursuant to Section 45 of PD 705, they are authorized to administer an oath  
... acknowledgement in official matters connected with the functions of their  
... and to take testimony in official investigations conducted under the  
... authority of the Revised Forestry Code of the Philippines and its implementing  
... and regulations.

They shall submit to the District Forester, Tagum, Davao del Norte  
... monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their  
... tenure of Office unless sooner terminated by this Office.
