By virtue of this deputation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest revelopment and to arrest, even without warrant, any person who has committed, is writing or is about to commit in your presence any of the offenses defined in one 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools a proment used in committing the offense and the forest products cut, gathered to be the offender/s in the process of committing the offense. In all the period detection, arrest and/or seizure or confiscations, they shall deliver the period prescribed by law from the time of arrest and seizure, the offender
