They are also authorized to seize/confiscate the tools absent used in committing the offense and the forest products cut, gathered products via by the offender/s in the progess of committing the offense. In all that it is of detection, arrest and/or seizure or confiscations, they shall deliver the period prescribed by law from the time of arrest and seizure, the offender.
