: Deputizing the Barangay Captains of Sta. Maria, Davao del Sur as Forest Officers of the Ministry of Natural Resources.

In accordance to Section 80 of Presidential Decree No. 705, the following are deputized as FOREST OFFICERS of the Ministry of Natural Resources/Bureau of Forest Development, effective upon receipt hereof, of which this Office shall be advised accordingly.

By virtue of this deputation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in Sections 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the offender/s in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender


appropriate officials designated by law to conduct investigation and file the information in court through the District Forester.

Section 45 of PD 796 is authorized to administer an oath and judgment in official cases connected with the functions of their office and to give testimony in official investigations conducted under the Department of Forestry of the Philippines and its implementing agencies.

They shall submit to the District Forester, Digos, Davao del Sur copies of the cases they have handled pursuant to this Order.

Their appointments shall be automatically revoked upon termination of their office unless sooner terminated by this Office.
