By virtue of this deputation, they are authorized to detect violations of country laws/rules and regulations administered by the Bureau of Forest Department and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in sections 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your assigned jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or taken by the offender/s in the process of committing the offense. In all cases of detection, arrest and/or seizure or confiscations, they shall deliver the same to the appropriate authority as prescribed by law from the time of receipt.
