By virtue of this deputation, they are authorized to detect violations of prestry laws/rules and regulations administered by the Bureau of Forest in year and to arrest, even without warrant, any person who has committed, is committely or is about to commit in your presence any of the offenses defined in petions 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your ritorial jurisdictions. They are also authorized to seize/confiscate the tools authorized in committing the offense and the forest products cut, gathered or reserved by the offender/s in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscations, they shall deliver the period prescribed by law from the time of arrest and coingree the offense.
