By virtue of this deputation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest Depoent and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in flows 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your forial jurisdictions. They are also authorized to seize/confiscate the tools of import used in committing the offense and the forest products cut, gathered to book you by the offender/s in the process of committing the offense. In all instances of detection, arrest and/or seizure or confiscations, they shall deliver

that with, the appropriate official designated by law to conduct in an investigation and file the information in court through the District in or Regional Director.

Fursuant to Section 45 of PD 705, they are authorized to administer an oath of take acknowledgement in official matters connected with the functions of their office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing only and regulations.

They shall submit to the <u>District Forester</u>, Koronadal, South Cotabato monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their are of Office unless sooner terminated by this Office.
