In all instances of detection

arrest and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with, the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forenter or Regional Director.

Fursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their puffice, and to take testimony in official investigations conducted under the cohority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Farester, Ormoc City a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their was of office unless sooner terminated by this Office.
