in wirtue of this deputation, they are authorized to detect violations of the and laws/rules and regulations administered by the Bureau of Forest Development * Prinat, even without warrant, any person who has committed, is committing or time to commit in your presence any of the offenses defined in Sections 68, 60, 77 of Presidential Decree No. 705, within your territorial jurisdictions. Sisc authorized to seize/confiscate the tools and equipment used in ithing the offense and the forest products cut, gathered or removed by the war/s in the process of committing the offense. In all instances of detection,

arrest and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with, the appropriate official designated by law to conduct prollmin by investigation and file the information in court through the District Forester or Regional Director.

Fursuant to Section 45 of PD 705, they are apphorized to administer an path are take acknowledgment in official matters compacted with the functions of them office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester, Basey, Samar a morally report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their ten re of office unless sooner terminated by this Office.
