In virtue of this deputation, they are authorized to detect violations of the laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or about to commit in your presence any of the offenses defined in Sections 68, 69, 70 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in the commission of offenses and the forest products gathered or removed by the offenders.


