The slace authorized to seize/confiscate the cools and equipment used in thing the offense and the forest products cut, gathered or removed by the time large in the process of committing the offense. In all instances of detection,

prescribed by law from the time of arrest and seizure, the offender and the confise cated forest products, tools and equipment too, and file the proper complaint with, the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester on Regional Director.

Fursuant to Section 45 of PD 705, they are authorized to administer an catherd take acknowledgement in official matters connected with the functions of their office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing tales and regulations.
