y virtue of this deputation, they are authorized to detect violations of the restry laws/rules and regulations administered by the Bureau of Forest Development to arrest, even without warrant, any person who has committed, is committing or about to commit in your presence any of the offenses defined in Sections 68, 69, 71, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in cormitting the offense and the forest products cut, gathered or removed by the allegar and the process of committing the offense. In all instances of detection.

per st and/or seizure or confiscations, they shall deliver within the period or sociated by law from the time of arrest and seizure, the offender and the cord. - cated forest products, tools and equipment too, and fill the proper complaint with appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Direct

Fursuant to Section 45 of PD 705, they are authorized to administer an paratilities, and to take testimony in official investigations conducted under the nutbority of the Revised Forestry Code of the Philippines and its implementing tables and regulations.

They shall submit to the District Forester, Maasin, Southern Leyte a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their tenure of office unless sooner terminated by this Office.
