In all instances of detection, prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Direct

Fursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of the confidence, and to take testimony in official investigations conducted under the pusherity of the Revised Forestry Code of the Philippines and its implementing takes and regulations.

They shall submit to the District Forester, Massin, Southern Leyte they report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their rear of office unless sooner terminated by this Office.
