Surpuant to Section 45 of PD 705, they are authorized to administer an oath unit take acknowledgement in official matters connected with the functions of the tribution, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing roles and regulations.

They shall submit to the a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their tenure of office unless sooner terminated by this Office.
