Iso authorized to seize/confiscate the cools and equipment used in thing the offense and the forest products out, gathered or removed by the reder/s in the process of committing the offense. In all instances of detections

arrest and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the corfi ~ cated forest products, tools and equipment too, and file the proper complaint with appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Direct

Fursuant to Section 45 of PD 705, they are authorized to administer an oath reduced acknowledgement in official matters connected with the functions of the fine, and to take testimony in official investigations conducted as a real-authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester, Tacloban City a senthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their tenure of office unless sooner terminated by this Office.
