SUBJECT : Deputizing the Barangay Captains of San Policarpo, Eastern Samar as Forest Officers of the Ministry of Natural Resources.

In virtue of this deputation, they are authorized to detect violations of the laws/rules and regulations administered by the Bureau of Forest Development first, even without warrant, any person who is committing or about to commit an offense against the laws/rules and regulations of the Bureau of Forest Development.

Offenses and the forest products cut, gained or removed by the persons in the process of committing the offense. In all instances of detection,

arrest and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of the Office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester, Dolores, Eastern Samar a monthly report of the cases they have handled pursuant to this Order.


This deputation shall be automatically revoked upon termination of their tenure of office unless sooner terminated by this Office.
