**SUBJECT : Deputizing the Barangay Captains of Palompon,
Leyte as Forest Officers of the Ministry of
Natural Resources.**

In virtue of this deputization, they are authorized to detect violations of the laws/rules and regulations administered by the Bureau of Forest Development. They may arrest, even without warrant, any person who has committed, is committing or attempts to commit in your presence any of the offenses defined in Sections 80, 81, 82, 83, 84, 85, 86, 87 of Presidential Decree No. 705, within your territorial jurisdiction. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the offender in the process of committing the offense. In all instances of detection,
