words and/or seizure or confiscations, they shall deliver within the period or scribed by law from the time of arrest and seizure, the offender and the confisforest products, tools and equipment too, and file the proper complaint with, appropriate official designated by law to conduct preliminary investigation ed file the information in court through the District Forester or Regional Director.

Fursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their · Wice, and to take testimony in official investigations conducted under the authority of the Revised Porestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester, Tacloban City a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be auto atically revoked upon termination of their tenure of office unless sooner ter inated by this Office.
