estry laws/rules and regulations administered by the Bureau of Forest Development to arrest, even without warrant, any person who has committed, is committing or about to commit in your presence any of the offenses defined in Sections 68, 69, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the offender/s in the process of posmitting the offense. In all instances of detection,

recet and/or seizure or confiscations, they shall deliver within the period sociated by law from the time of arrest and seizure, the offender and the confisced forest products, tools and equipment too, and fild the proper complaint with, the appropriate official designated by law to conduct preliminary investigation and tile the information in court through the District Forester or Regional Director.

Forsuant to Section 45 of PD 705, they are authorized to administer an oath the acknowledgement in official matters connected with the functions of their rections, and to take testimony in official investigations conducted under the matter of the Revised Forestry Code of the Philippines and its implementing the and regulations.

They shall submit to the District Forester, Tacloban City

This deputation shall be automatically revoked upon termination of their tenure of office unless sooner terminated by this Office.
