They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the first and equipment to arrest, even without warrant, any person who has committed, is committing or about to commit in your presence any of the offenses defined in Sections 68, 69, 71 and 77 of President al Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the offender/s in the process of committing the offense. In all instances of detection,

and/or seizure or confiscations, they shall deliver within the period priced by law from the time of arrest and seizure, the offender and the confiscers are products, tools and equipment too, and file the proper complaint with, appropriate official designated by law to conduct preliminary investigation dile the information in court through the District Forester or Regional Director.

Fursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their office, and to take testimony in official investigations conducted under the nuthority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall subwit to the District Forester, Tacloban City

This deputation shall be automatically revoked upon termination of their tenure of office unless somer terminated by this Office.
