The also authorized to setze/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the lander's in the process of detection Corder's in the process of committing the offense. In all instances of detection,

and/or seizure or confiscations, they shall deliver within the period of writed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with, the appropriate official designated by law to conduct preliminary investigation file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester, Borongan, Eastern Samar a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatical y revoked upon termination of their tenure of office unless somer terminated by this Office.
