By virtue of this deputation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or about to commit in your presence any of the offenses defined in Sections 68, 69, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. are also authorized to seize/confiscate the tools and equipment used in corritting the offense and the forest products cut, gathered or removed by the lander/s in the process of committing the offense. In all instances of detection,

present and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with, appropriate official designated by law to conduct preliminary investigation in like the information in court through the District Forester or Regional Director

Fursuant to Section 45 of PD 705; they are authorized to administer an oath take acknowledgement in official matters connected with the functions of their c, and to take testimony in official investigations conducted under the lty of the Revised Forestry Code of the Philippines and its implementing and regulations.
