By virtue of this depotation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or and to arrest, even without parrant, any person who as committed in Sections 68, 69, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the effenser/s in the process of committing the offense. In all instances of detection, are at and/or seizure or comesquations, they shall deliver within the period wited by law from the time of arrest and seizure, the offender and the confisforest products, tools and equipment too, and file the proper complaint with, repropriate official designated by law to conduct preliminary investigation the information in court through the District Forester or Regional Director.

Parsuant to Section 45 PD 705, they are authorized to administer an oath acknowledgement in official matters connected with the functions of their fine, and to take testimony in official investigations conducted under the withority of the Revised Forestry Code of the Philippines and its implementing : :les and regulations.

They shall submit to the District Forester, Dolores, Eastern Samar a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their tenure of office unless soonen terminated by this Office.
