By virtue of this deputation, they are authorized to detect viciations of the Stry laws/rules and regulations administered by the Bureau of Forest Development to arrest, even without warrant, any person who has committed, is committing or about to commit in your presence any of the offenses defined in Sections 68, 69, 71, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the offender/s in the process of committing the offense. In all instances of detection,

and/or seizure or confiscations, they shall deliver within the period by law from the the of arrest and seizure, the offender and the confiscent products, took and equipment too, and file the proper complaint with, compriste official designated by law to conduct preliminary investigation the information in court through the District Forester or Regional Director.

They shall submit to the District Forester, Massin, Southern Leyte a monthly report of the cases they have handled pursuant to this Order.
