Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in efficial matters connected with the functions of their office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester of Sipocot. Camarines Surmonthly report of the cases they have handled pursuant to this Order.
