They are also authorized to seize/confiscate the tools and equipment used in committen; the offense and the forest products cut, gathered or removed by the Clender/s in the process of committing the offense, In all instances of detection,

product and/or seizure or confiscations, they shall deliver within the period production by law from the time of arrest and sei are, the offender and the confiscal deliverest products, tools and equipment too, and file the proper complaint with, the open priate official designated by law to conduct preliminary investigation and the life the information in court through the District Forester or Regional Director
