by virtue of this deputation, they are authorized to detrot violations of the forestry laws/rules and regulations administered by the bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the attendes defined in Sections 68, 69, 70, 70 and 77 of Presidential Decree 68. 70%, within your territorial jurisdictions. They are also authorized to not 20/confiscate the tools and aquipment used in committing the offense and the forest products cut, gathered or removed by the off nder/s in the process of secunitting the offense. In all instances of detection, arrest

,

and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, beels and equipment too, and file the proper complaint with, the appropriate of idial designated by law to conduct preliminary investigation and file the information in court through the District Perester or Regional Director.

Fursuant to Section 45 of JD 705, they are authorized to administer an onth and take asknowledgement in official matters connected with the functions of their office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester of Sorsogon, Sorsogon monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their tenure of office unless somer terminated by this Office.
