**SUBJECT : Deputizing the Barangay Captains of Ubay,  
Bohol as Forest Officers of the Ministry of  
Natural Resources.**

Pursuant to Section 80 of Presidential Decree No. 705, the following are  
designated as FOREST OFFICERS of the Ministry of Natural Resources/Bureau of  
Forest Management, effective upon receipt hereof, of which this Office shall be  
informed accordingly.

By virtue of this deputation, they are authorized to detect violations of  
country laws/rules and regulations administered by the Bureau of Forest  
Management and to arrest, even without warrant, any person who has committed, is  
committing or is about to commit in your presence any of the offenses defined in  
Presidential Decree No. 705, under the  
provisions. They are also authorized to deputize other  
persons to detect and arrest forest products thieves, and  
to prevent and suppress the offense of  
...

... prescribed by law from the time of arrest and seizure, and to  
seize forest products, tools and equipment too, and file the proper

... or seizure or confiscations, they shall deliver within the period ... by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.


They shall submit to the District Forester, Tagbilaran City monthly report of the cases they have handled pursuant to this Order.
