In virtue of this deputation, they are authorized to detect violations of the laws/rules and regulations administered by the Bureau of Forest Development. In the event, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in Sections 68, 69, 70 and 72 of Presidential Decree No. 705, within your territorial jurisdictions, you are authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the offender in the process of committing the offense. In all instances of detection,

... and/or seizure or confiscations, they shall deliver within the period
... by law from the time of arrest and seizure, the offender and the confis-
... products, tools and equipment too, and file the proper complaint with,
... appropriate official designated by law to conduct preliminary investigation
... the information in court through the District Forester or Regional Director.

... and to Section 45 of PD 705, they are authorized to administer an oath
... acknowledgement in official matters connected with the functions of their
... to take testimony in official investigations conducted under the
... of the Revised Forestry Code of the Philippines and its implementing
... regulations.


... shall submit to the District Forester, Dipolog City
